TERMS AND CONDITIONS

The undersigned does hereby agree to the following terms:

1. To hold the City of Wausau, its officials, agents and employees harmless and release them from any and all personal injuries, deaths, and/or property damages occurring while the Fire Safety House Unit and Towing Vehicle are in the possession of the lessee.
2. To return the Fire Safety House Unit and Towing Vehicle to the Wausau Fire Department promptly within the time frame of this agreement in good condition; clean and without damages. The Fire Safety House Unit and Towing Vehicle shall be inspected upon pick up and return to note any changes in the condition. Unsatisfactory conditions found will be invoiced to the applicant at the actual cost for cleaning, repair or replacement of damaged areas and/or unsatisfactory conditions.
3. To use only liquid smoke generating products supplied by the Wausau Fire Department.
4. To be responsible for all equipment, displays, etc., supplied with the Fire Safety House Unit and Towing Vehicle, and to return them in good working condition without damage to the Wausau Fire Department. The Fire Safety House Unit and Towing Vehicle shall be inspected upon return and damages found will be invoiced to the applicant at actual cost of repair or replacement of the damage.
5. To operate the Fire Safety House Unit and Towing Vehicle safely, obeying all traffic regulations and speed limits, at safe and reasonable speeds, but **not to exceed 35 miles per hour** while moving the units.
6. To provide collision, comprehensive and liability insurance coverage listing the City of Wausau as an additional insured with limits of not less than **\$250,000**.
7. To forbid anyone other than an authorized member of a Fire Department to operate and demonstrate the Fire Safety House Unit and Towing Vehicle.
8. To forbid the use of the Fire Safety House Unit and Towing Vehicle outside the immediate response jurisdiction of a Fire Department for purposes other than towing it from and to the Wausau Fire Department.
9. To provide payment of \$100 to cover the cost of gas and smoke fluid used.

I hereby agree, in consideration of this agreement, to comply with the stated terms. Additionally I agree to abide by the laws of the Federal Government, State of Wisconsin, City of Wausau and the rules and regulations of the various regulatory agencies and commissions pertaining to the activities permitted under this agreement for which this application is being made.

I understand the Fire Chief and/or his designees have the right to terminate this agreement for actual or perceived safety concerns; procedural issues or concerns; violations of any rules or regulations after the lease has been signed. I accept full responsibility for strict adherence of all rules, regulations, laws and ordinances of federal, state and local authorities.
