Minutes of previous meetings. (8/17/20)

Motion by Peckham, second by Herbst to amend and approve the minutes of the previous meeting on 8/17/20, to change the word “comfortable” to “uncomfortable” in a comment by McElhaney on page 2. Motion carried 5-0.

Consider approval or denial of various license applications.

Rasmussen stated there was one Operator’s License application recommended for denial for Justin Zastrow. It was noted Mr. Zastrow was not present to appeal.

Motion by Wadinski, second by Herbst to approve or deny licenses as recommended by staff. Motion carried 5-0.

Consider request for waiver of 3.06.010 Payment of taxes, claims, forfeitures, judgments prior to issuance of license or permit. (Frances Howe)

Rasmussen noted this request was carried over from the last meeting to give Ms. Howe the opportunity to be present to answer questions. The delinquent bill is \$1,330.52.

Frances Howe, 231 N 9th Ave, stated she needs her Public Transport Driver License to work so she can make payments on her water bill. Rasmussen questioned how long the water bill has been accumulating. Howe indicated since the previous year when she was in an accident. Committee discussion was for Ms. Howe pay off the water bill prior to renewal of the license for next year. (*Note: The Public Transport license year runs July 1st – June 30th*)

Motion by Peckham, second by McElhaney to approve the waiver for Frances Howe to obtain her Public Transport Driver license and that the license not be renewed if the balance is not paid in full. Motion carried 5-0.

(*Note: Delinquent water bills are transferred to the owner’s property taxes on November 15th of each year. Frances Howe is a tenant and is not the owner of the property.*)

Discussion and possible action on Ordinance amending Section 8.08.170 Licenses

Rasmussen stated these are housekeeping cleanup revisions to the animal ordinance in reference to pet licensing.

Motion by Wadinski, second by McElhaney to approve the ordinance. Motion carried 5-0.

Operations Report from Fire Department for August 2020

Wadinski stated the media reported there was a second response from outlying communities to the Linetec factory fire last week. He questioned what that entails and whether the city would ever have to respond to those communities.

Chief Kujawa explained the fire was a significant event and this was a Mutual Aid Box Alarm System, which was put in effect four or five years ago. It has five different alarms and gives you access to different resources, whether it’s fire trucks, ladder trucks, engines, ambulances, rescue squads, or other command staff. In this particular case our Incident Commander called for a second box alarm to get engines, ladders, ambulances, and incident commands from area departments. She indicated he also called a second box alarm which took us to Merrill and Stevens Point and Marshfield to get additional resources. It was that big that additional resources were needed to rotate inside the building and for rehabilitation. She noted there were at least 10 or 12 departments present. She stated we normally only request one resource from each department, so as not to diminish their ability to respond. The Wausau Fire Department is on the box alarms of many fire services in Marathon County and outside of it.

Comments on Proposed Draft of Amending Section 9.04.025 Consumption or possession of intoxicants on streets.

- The City of Wausau's current ordinance prohibits an individual from consuming or possessing an open container while in or upon any public street, public parking lot, alley, sidewalk or other public right-of-way.
- There was some confusion as to if this ordinance applied to private parking lots that are held open to the public, such as parking lots connected and owned by various bars and restaurants.
- This ordinance is meant to clear up that confusion.

Section 1. That Section 9.04.025 Consumption or possession of intoxicants on streets, is hereby amended to read as follows:

9.04.025 Consumption or possession of intoxicants on streets.

....

(d) The consumption of any alcohol beverage or possession of a container which is open and contains an alcohol beverage, as defined by chapter 125 of the Wisconsin Statutes, in any private parking lot or facility held open to the public shall be prohibited unless permission has been granted by the owner or designees and such consumption is not in violation of Wis. Stat. 125.09(1) of that chapter.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall be in full force and effect from and after its date of publication.

The Common Council of the City of Wausau do ordain as follows:

Section 1. That Section 5.90.010 Purpose and intent is hereby amended to read as follows:

5.90.010 Purpose and intent. The Common Council recognizes . . . Therefore, notwithstanding any provision contained within the City of Wausau Municipal Code, during the period of emergency and recovery in response to COVID-19 and expiring on ~~October 31, 2020~~, **December 31, 2020**, 11:59 pm, the Common Council implements the temporary rules contained in this chapter. . .

Section 2. That Section 5.90.040 Temporary amendment of licensed premises is hereby amended to read as follows:

5.90.040 Temporary amendment of licensed premises.

. . .

(b) Expiration of temporarily expanded area. The temporarily expanded licensed premise area shall be effective only for a time period expiring ~~October 31, 2020~~ **December 31, 2020** at 11:59 pm or while the licensee holds a valid temporary sidewalk café permit under this chapter, whichever occurs first. Upon termination, relinquishment, revocation or suspension, or other expiration of the temporary sidewalk café permit or at 11:59 pm on ~~October 31, 2020~~ **December 31, 2020**, whichever occurs first, the licensed premise area shall automatically return to the area identified and approved as part of the licensee’s annual license application without further action required upon the part of the licensee or Common Council. . .

(c) Additional temporary licensed premises amendment for special event participation. Any restaurant as defined in section 5.63.020(c) of this Code holding an alcohol beverage license and either a sidewalk café permit under section 5.64.035 or a temporary sidewalk café permit under this chapter, that is part of an approved special event under the City’s Special Events Policy & Procedure may apply for an

additional temporary amendment of licensed premises as provided and limited herein to include an area located within the parking stalls in the public street or roadway adjacent to its licensed premises and sidewalk café.

(1) Limitation on event. To be eligible for a temporary amendment of licensed premises under this subsection, the approved special event must be authorized and provide for closure of the street which encompasses the parking stalls to vehicle traffic; shall provide satisfactory access for emergency vehicles; be approved for an exemption from the prohibitions against consumption or possession of intoxicants on street under section 9.04.025(c); and, while the event may be a repeating event occurring on a weekly basis the series of which shall conclude no later than ~~October 31, 2020~~, **December 31, 2020**, each individual event in the series must be of a duration not to exceed a 6 hour time period one day per week, excluding set up and take down.

Section 3. That Section 5.90.060 Temporary outdoor operation for bars and taverns is hereby amended to read as follows:

5.90.060 Temporary outdoor operation for bars and taverns.

...

(b) Temporary amendment of licensed premises.

...

(3) Expiration of temporarily expanded area. The temporarily expanded licensed premise area shall be effective only for a time period expiring ~~October 31, 2020~~ **December 31, 2020** at 11:59 pm or while the licensee holds a valid temporary sidewalk café permit under this chapter, whichever occurs first. Upon termination, relinquishment, revocation or suspension, or other expiration of the temporary sidewalk café permit or at 11:59 pm on ~~October 31, 2020~~, **December 31, 2020**, whichever occurs first, the licensed premise area shall automatically return to the area identified and approved as part of the licensee's annual license application without further action required upon the part of the licensee or Common Council. . .

Section 4. All provisions of City ordinances not specifically altered by this temporary ordinance shall remain in effect.

Section 5. These ordinances shall be in full force and effect on the day after its publication.

Section 6. **These ordinances shall automatically repeal on December 31, 2020 at 11:59 pm; no further action shall be required.**



NOTABLE INCIDENTS AT TAVERNS TO WHICH POLICE WERE DISPATCHED.

6th Street Pub, 2002 N. 6th Street

- (1) *Event #20115382, 09/13/2020 at 1:56 AM:* A **bartender** called to request assistance in removing two people that refused to leave the bar. On officers' arrival, the two people, a couple, were standing outside. The male and female were highly intoxicated, it was difficult to obtain their version of events. Bob & Randy's Bar, 1515 N. 6th Street

- (1) *Event #20110123, 09/01/2020 at 5:32 PM:* A citizen called to report that he was at the bar at the same time as another male who was making threats over text messages. The subject also had a restraining order against the reporting party's sister. When officers attempted to contact the reporting person, they were unable to speak with him. The reporting person did not call back in, and no further action was taken.
- (2) *Event #20122787, 09/27/2020 at 9:24 PM:* A refused complainant reported observing a male passed out on the front step of the bar. Officers responded and located the male, a known homeless person. The officer assessed his well-being, and upon finding that he was fine, asked him to move along.

Intermission Bar, 325 N. 4th Street

- (1) *Case #20007115, 09/12/2020 at 9:26 PM:* The **bar manager** called to report that a male in the bar had been armed with a knife, presented it, and made a gesture indicative of slashing a throat with it. The male was known by the bartender, and a description was provided for officers. At the time of the call, the reporting person noted that it had been 15 minutes since the incident had occurred. Officers located the suspect at another bar (Oz) and detained him while the investigation continued. The knife was not located on his person. The bartender at Oz noted that the suspect had left the bar for a short time, walking to the west, and then returned to the bar. Officers checked the planters and garbage cans along Washington Street and located what they believed to be the knife that was used, hidden in a planter. The male was arrested and jailed for carrying a concealed weapon, disorderly conduct and a probation hold. Although it is certainly appropriate for the bartender/manager at Intermission to have called the police, I question the timing. In the notes entered by the dispatcher in the call, the reporting person admits there was a 15 minute delay. When reviewing camera footage of downtown surveillance, it appears that a total of 30 minutes had passed since the suspect left Intermission and officers were dispatched to the call. In addition, the bartender of Oz stated that he had received a text from Intermission, warning them of the situation. I think such communication is important and beneficial, although in this case I question whether it is in the best interest of the community that they are apparently more concerned about warning each other than notifying the police about the incident. This is the same bar manager that claimed she did not know anyone that may have been driving a scooter that was reported to have crashed near the bar last month. Further investigation of that incident led to the discovery that the operator of the scooter was a bartender at the bar.

Loppnow's Bar, 412 N. 3rd Street

- (1) *Event #20121963, 09/26/2020 at 1:48 AM:* A **bartender** called to report that there was a female outside and in front of the bar acting erratically, walking in the street. She came into the bar, however they did not serve her. Officers located the woman, and described her as presenting as paranoid and delusional. When officers arrived many people had already left the scene, and no disturbance was taking place. Officers reported observing vehicles leaving the area as they arrived, however no information had been given regarding people involved in the fight. At the scene, officers observed evidence of a very physical altercation, including jewelry, a broken beer bottle, the pool cue suspected as being used in the fight, and blood spatter. One of the women involved that sustained injuries later called, however declined to pursue any charges. A male that was also contacted with the female admitted having been involved in the altercation. He also declined to pursue charges. A video of the altercation was later located on social media. It depicted a large altercation that lasted several minutes, causing me to question why the bar employees did not call sooner. According to the call log, it took 30 seconds for the call to be dispatched from the time it was received, and approximately 2 ½ minutes for the first officer to arrive on scene. This is the second fight this month at this tavern. I recommend assessing **fifty (50) demerit points** for failure to maintain orderly premises, disorderly conduct within premises and failing to summon police or intervene to prevent future violations.

Chatterbox Bar, 102 S. S 2nd Avenue

- (1) *Case #20007477, 09/24/2020 at 7:19 PM:* A bartender called to report that there was a male at the bar refusing to leave, who was clearly under the influence of something. The bartender reported that they were not serving the male. Officers responded and located the male, and determined that the male was under the influence of methamphetamine. He was suffering from delusions and paranoia, fearing that he was being chased and somebody was trying to hurt him. He's eventually taken into custody on an emergency detention and transported to an out of county facility.

Labor Temple, 318 S. 3rd Avenue
