WMC section 23.56.050(2)(B) requires a site development plan prior to issuance of a zoning permit for a property that is regulated by the floodplain district. After completion of your project, a Certificate of Compliance shall be issued. You, as the property owner or authorized agent, shall submit a certification signed by a registered professional engineer or registered land surveyor that the fill, lowest floor, and flood proofing elevations are in compliance with the permit issued.

**Wetlands Notice to Permit Applicants:** You are responsible for complying with State and Federal laws concerning the construction near or on wetlands, lakes, and streams. Wetlands that are not associated with open water can be difficult to identify. Failure to comply may result in removal or modification of construction that violates the law or other penalties or costs.
