## **RULES OF CONDUCT**

### **WAUSAU POLICE RIDE ALONG PROGRAM**

Participants in the Wausau Police Department Ride-Along Program shall comply with all the Rules of Conduct listed below and must sign the Release of Liability on the back side of this form. Minors must have the Release Form signed by one or both parents or a legal guardian.

This form must be presented to the supervisor on duty at the time of the ride.

#### **RULES OF CONDUCT:**

Riders must be at least 18 years of age. If an exception is granted to the age requirement, a parent/guardian must be present to complete the ride-along form.

Riders will not in any way interfere or assist the officer unless their aid is requested.

Riders will not be allowed to be present on juvenile cases where records and arrests are, by law, confidential.

Riders will not be allowed to be present during interviews of a serious criminal incident such as a homicide or morals offense.

Riders will not be allowed to be present during any interrogation on a criminal matter.

Riders will not enter into or upon any person's private property or residence where officers are responding to a disturbance or complaint.

Riders will not leave the police car without the permission of the officer.

Riders must wear appropriate attire, appearing neat and well-groomed. Collarless shirts are not permitted. Pants cannot be raggy, over-sized, or have holes. Riders not conforming to appearance standards will be denied participation in the Ride-Along Program.
